The Strategy

Carl von Clausewitz was a German general who is considered the father of modern western strategic studies and, for this reason, is used as a source of inspiration in management schools. He said that military strategy is the employment of battles to gain the end of war.

Wars are also those shared between children in the hot bothering Italian afternoons who typically find other kids

looking for trouble.

When I was 10 years old, my grandparents took me to the seaside for a few days every year. As a child I did not have a choice, but, at the same time, a change of scenery brought

After a few days, I went back home and did not see Pierluigi again. Ambition is good, but first learn and then aim for success.






René and Gilles

again, I would do it again."

René, with his pungent humor, said, "I only know that if you were there instead of Gilles, I would have come second and not third!" and then they both walked away.

of age he builds Swiss watches. What a

Experience and Discipline Lessons:

Red Team

The purpose of a red team is to get a group of people to review a particular plan or decision being frank about his or her findings and to tell you why he or she think it will not work and where weaknesses may be. Red teams play the devil's advocate where errors and weaknesses are exposed before decisions are made and executed. If possible, Red Team members should not have any connection or awareness of the project or any collaboration that took place to create the plan.

Duke says, "The fundamental point of red teaming is simply to seek out someone that isn't biased toward your position to review your work and provide candid feedback." Performing red teams can be an uncomfortable process if not handled appropriately.

- 1. Present details of the plan to the red team
- 2. Provide an opportunity for members of the red team to ask clarifying questions.
- 3. Allow red team to provide criticism of the plan by phrasing their critical comments as an inoffensive question beginning "Have you considered..."
- Accept all red team comments by writing them down but do not argue or start a debate with the red team
- 5. Once red team has completed critical comments, thank each one of them for their assistance and dismiss them from the meeting.
- Review all red team's comments with your team and determine which comments you will address to improve your plan.

Assess to Iterate, Improve and Accelerate Experience

- 1: **Leaders Admit Errors:** Great leaders are not afraid to admit when you are wrong. When you do that, you actually gain trust and confidence in your team. It shows you are human and that you are not trying to elude accountability.
- 2: **Debrief to identify and learn from root causes:** Debriefing or conducting After Action Reviews is a proven technique that will enhance and improve the teams performance. By conducting these within your team you will learn what root causes come about at which point you should work to find solutions. Root causes that you can always draw back to consist of: 1) Leadership 2) Organization 3) Communication 4) Knowledge 5) Experience 6) Discipline

Prioritize

You can't do everything nor should you. "Priorities matter. As a leader you must decide what the most important things are and focus your energies on those things. Otherwise, you will task saturate yourself and your team and burn out," said Duke.

- 1: Design the Future: Leaders must describe the future and where they are heading. Leaders should help everyone envision the future with enough detail so that it provides a clear intent about what needs to happen.
- 2: Identify a Strategy: Leaders should facilitate with their team the best strategy to achieve the goal. Michael Porter says, "The essence of strategy is choosing what not to do". Remember it is better to have a Grade B in strategy with a Grade A in execution. Don't over analyze. If you conduct weekly debriefs/AAR's with your team and have a Grade B strategy it will ultimately become a Grade A strategy as you are adapting based on lessons learned.
- 3: Importance and Urgency: Act with a sense of urgency. President Dwight Eisenhower said, "I have two kids of problems, the urgent and the important. The urgent are not important, and the important are never urgent." What is the difference for you between urgent and important? One way to decipher is put them into 4 areas: 1) Important and Urgent: Do it immediately 2) Important, but not urgent: Set a suspense date 3) Unimportant but urgent: Delegate it to some else 4) Unimportant and not urgent: Drop it
- **4: Task Shed:** Inventory the things you do, prioritize them, and suspend or stop doing those things as the circumstances demand. Task shedding can be organized into 4 areas: 1) Must Do: Things you never fail to do 2) Should Do: These are almost 'Must Do's" but dropping one every so often is not the end of the world 3) Good to Do: Value added activities but are not specifically critical and can be suspended during high areas of task saturation 4) Don't Do: Stop doing them now, they add no value. If they are not in your lane stop involving yourself unless it is for the betterment of the overall team.
